

ACAExpress.com Services License Agreement Standard Implementation

This Services License Agreement (Agreement) details the services to be provided to Licensee for the ACA (Affordable Care Act) ACAExpress enrollment platform.

Transaction Fees

Completed transactions are billed as transactions occur using the payment method provided by you at the rate of \$12.50 per completed application.

Upgrading to Pro Express Implementation

User may upgrade to the Pro Express implementation at any time by agreeing to and paying any applicable fees for the then applicable Pro Express Services Agreement.

Term

- A. Agreement Term. The term of this agreement is month to month.
- B. Service Licenses and Subscription Fees. You will pay all Fees and other charges described and otherwise referenced in this Agreement, at the time such Fees are due.
- C. ACAExpress may terminate this agreement at any time at its sole discretion for reasons of non-payment or violation of any portions of this or other agreements with User.

If you are entering into this Agreement on behalf of an entity, you represent that you have the authority to bind such entity to this Agreement. You may not access any Services unless, and by accessing the Services you represent and warrant that, you (1) if an individual, are at least 18 years of age, (2) are not in any manner affiliated with a direct competitor of ACAExpress.com, (3) will not access the Services to monitor their availability, functionality, or for any other benchmarking or competitive purposes, (4) or any entity that you are affiliated with, have not at any time breached a contract with ACAExpress.com, and (5) accept and agree to be bound by the provisions of this Agreement and the End User License Agreement.

Billing Errors

You must contact ACAExpress.com in writing no later than 60 days after the date of the applicable invoice to report a billing error. If notice is not received within 60 days of the date of the invoice, you waive any right to an adjustment or credit.

Jurisdiction and venue.

The laws of the State of Texas, county of Tarrant, will be used to construe this Agreement. Licensee consents that exclusive jurisdiction and venue shall exist in the aforementioned state and county for the purpose of adjudication of disputes arising out of this EULA.
